IMPORTANT CHANGE TO THE ADMINISTRATION OF YOUR MICHIGAN LABORERS' BENEFITS

To: All Participants of The Michigan Laborers' Fringe Benefit Funds

Re: Michigan Laborers' Fringe Benefit Funds – *New Third-Party Administrator – Wilson-McShane Corporation (WMC) Effective September 1, 2026*

Dear Participants:

We are pleased to announce that, effective September 1, 2026, the administration of the Michigan Laborers' Fringe Benefit Funds will transition to WMC.

A third-party administrator (TPA) is an organization that handles the day-to-day operations of pension, annuity, health, vacation and other benefit plans by performing benefit application processing, determining eligibility for benefits, and entering data related to contributions and participant and beneficiary information.

Last year, we conducted a rigorous and lengthy search for a new TPA that would provide dedicated, high-quality, and modernized services to our participants. We chose WMC given their proven track record of providing first-class administrative services to multi-employer plans nationally, their staff's expertise in benefit administration, and enhanced technology and cybersecurity.

Below, we describe in further detail how the engagement of WMC will affect you.

Please Note: This transition to WMC will *not* affect your pension, annuity, health care or vacation benefits. That is, your eligibility and benefit levels will remain the same.

1. Michigan Office

The Michigan Laborers' Fringe Benefit Funds will continue to have the dedicated Fund Office located at:

Please note: The office will be closed to walk-in traffic from August 24 through August 31.

This office will continue to be open Monday through Friday from 8:00 a.m. to 5:00 p.m. (EST) and will serve the Michigan Laborers' Fringe Benefit Funds. You will also be able to continue contacting the Fund Office during business hours by calling 877-645-2267 (877-MILABOR).

3. Health Care Fund Self-Payments – Actives, Early Retirees, Medicare Retirees, Disabled Participants and Surviving Spouses

Beginning with your September 2026 Self-Payment for October Fund coverage, *please submit your self-payment by:*

- **Check** – Please mail your check to: Michigan Laborers' Health Care Fund, 6452 Millennium Drive, Suite 100, Lansing, Michigan 48917.
- **Credit Card** – Please call 877-645-2267 (877-MILABOR) to provide your credit card information over the phone to the Fund Office.
- **Pension Deduction** – If you are a retiree and your monthly self-payment is currently being deducted from your pension check, there is nothing for you to do. That is, these pension deductions will continue.

4. Participant Portal

Your current participant login for the Michigan Laborers' Fringe Benefits Funds participant portal will be deactivated on September 1, 2026. We encourage all participants to create a new account on WMC's participant portal.

Just like the current portal, the new participant portal provides real-time online access to all your Michigan Laborers' benefits, and will allow you to view the following:

- Eligibility and benefit status
- Your benefit payment status
- Contribution tracking
- Your contact information

- Dependent status
- Pension benefit information
- Access to Plan documents, forms and applications
